

WHERE

The Sunflowersm Balloon Fest is held at Anthony, Kansas (downtown Anthony and Anthony Airport). The Celebration begins on Friday evening and will conclude on Sunday morning.

WHEN

The Sunflower Balloon Fest will be held on May 10-11-12, 2019. Sunday the event is over after the balloons fly in the morning.

BOOTH SIZE

Each booth is approximately 20 X 10 according to your needs. You tell us what you need so we know if we can accommodate that size. We cannot block the sidewalk.

SETUP

Each food vendor may set up on Friday anytime, but no later than 10 a.m. Saturday morning. You may have more than one space if needed. You must let us know. \$50 for each space.

ELECTRICITY

Electricity is available to food vendors only if you make prior arrangements. No electric is available for non-food vendors

COST

ALL FOOD VENDORS - \$50 with or without electricity (NO EXCEPTIONS). Depending on weather we will ask 3 vendors to serve at the airport. Let us know if you prefer in town or at the airport.

CANCELLATIONS

Cancellations are appreciated by April 30, 2019. No refunds after April 30! Each food vendor will be assigned a booth space on a, "First Come – First Serve Basis".

Vendor Applications will be accepted until Wednesday, May 1, 2019. Late applications WILL NOT be accepted.
